- 1) Separate Bids will be given for Multinational Companies, National Companies, and Surgical/Disposables on basis of Maximum Discount from retail price.
- 2) Separates Bids are invited for Frame work contract of Local Purchase of Medicines/Surgical/Disposables day to day for THQ Hospital Daska and local purchase of medicine (day to day) for Medical Social Welfare Office THQ Hospital Daska as per schedule mentioned above.
- 3) Bidding shall be conducted through Open Competitive Bidding (Single Stage-Two Envelope) procedures specified in the Punjab Procurement Rules PPRA 2014 (amended up to date). Health Departments Letter No. PSHD-TCO-I (M) 6-14/2017 dated: 16-Dec-2017 regarding Policy and Operational Guidelines for Local Purchase of Medicines (Day to Day) shall govern the LP.
- 4) Complete set of bidding documents may be purchased on submission of a written application to the undersigned on payment of a non-refundable fee of Rs.1000/-. If a tenderer desires to participate in both the biddings he has to deposit the fee separately.
- 5) Both the bids can be purchased from the office of the Medical superintendent THQ Hospital Daska before 02:00 p.m. till 21st September, 2021 for social welfare office THQ hospital Daska and 02:00 p.m. 22nd September 2021 for MS THQ hospital Daska.
- 6) Schedule of Bid closing date, Bid opening date and bid security amount for both the biddings are mentioned in the schedule above which should be strictly followed. No bid will be accepted without bid security which will be in the form of Irrevocable CDR/pay order/bank draft as per schedule above in favor of Medical Superintendent THQ Hospital Daska from a scheduled Bank of Pakistan and shall be submitted along with financial bid.
- 7) Tenderer should be registered with income tax and sales tax authorities and should provide NTN and active tax payer profile. Taxes will be deducted as per applicable government rules.
- 8) The Procuring Agency reserves the right to reject all bids or proposals at any time prior to the acceptance of bid or proposal under PPRA rule 64A.
- 9) The Procuring Agency has the due right to disqualify a supplier or contractor if it finds at any stage that information submitted by him was false/in accurate /in complete under PPRA rule 19.
